Following the election, Board officers (President, Vice-President, Secretary, and Vice-Secretary) are elected by a vote of the Trustees to serve.

2019 Trustee Election Candidate Information

Starting Date for Filing: **January 16, 2019**

Ending Date for Filing: **February 15, 2019**

Requirements to hold office:

- Be a qualified (registered) voter [Education Code 11.061 (b)]
- Take the official oath of office [Education Code 11.061 (a)]
- Serve without compensation [Education Code 11.061 (d)]
- Have been a continuous resident of the state for twelve months and a resident of the District for six months prior to the last date a candidate may file to be listed on the ballot. [Election Code 141.001 (a) (5)]

Application Procedures:

- Any individual who meets the above requirements may pick up a filing packet from the Mathis ISD Superintendent's Office, 602 East San Patricio Ave., Mathis, Texas 78368
- Applications must be signed, notarized, and state the place for which the applicant is a candidate (ex. Place 1, Place 2 ...) the term of office for School Trustees is four years.
- All applications filed are public records and open to inspection upon request.
- Completed applications must be filed at Mathis ISD Administration Office.

2019 Candidate Information Trustee Election May 4, 2019.

Notice is hereby given that on January 21, 2019 the MISD Board of Trustees, at a regularly scheduled Board Meeting, Called to Order Trustee Election May 4, 2019.

The First day to file for a place on the ballot was January 16, 2019.

The filing deadline was at 4:30 p.m. on February 15, 2019.

Election Packets were available for pick-up at the MISD Administration Building beginning on Wednesday, January 15, 2019, during the regular business hours of operation M-F, 7:30 a.m. to 4:30 p.m..

Election packet contained an "Application for a Place on the Mathis ISD General Election Ballot"; an "Appointment of a Campaign Treasurer by a Candidate" (form with instructions); the "MISD Election Advisory Calendar of Events/Deadlines/Dates"; and other pertinent information and forms needed for a Candidate running for School Board Trustee.

The Candidate Application and the Campaign Treasurer Appointment forms MUST be returned by the filing deadline. If any Candidate is opposed after the filing deadlines have passed, a ballot position drawing will be held in the Board Room of the Administration Building, 602 East San Patricio Ave., Mathis, Texas 78368 on February 25, 2019 at 10:00 AM.

Should all Candidates be unopposed after the filing deadlines have passed, the Board will declare the unopposed Candidates elected to office and Cancel the Trustee Election. Campaign Finance Reports and Filings are the responsibility of the Candidate and must be done in a timely manner. Forms for these filings are enclosed and the filing deadlines are shown on the Election Advisory Calendar. Posted
